The deductible is Non-Embedded. If you have other family members on the plan, the overall family deductible must be met before the plan begins to pay. Deductible year runs 07/01 – 06/30</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preventive care services are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. Does this plan provide Minimum Essential Coverage? **Yes**
